<u>PAYMENT</u> - Completed application forms and fees due should be submitted to the Treasurer along with a copy of a valid insurance certificate. Cheques made payable to **Burntisland Sailing Club**.

ENTRANCE FEE - The entrance fee applies to all new applications and is calculated as 25% of the annual subscription for the class of membership required.

Members who have not renewed their membership by the 31st of January 2017 will be notified by registered post of a failure to renew. Should the fees remain unpaid as of 14th of FEBRUARY 2017 the membership will be considered as lapsed and be required to rejoin with payment of the appropriate Entrance Fee.

ADULT MEMBERSHIP – Adult member aged 16 years or over

YOUTH MEMBERSHIP – A youth member aged 12 years or over and not over 15 years.

HOUSEHOLD MEMBERSHIP - Open to a group of members normally residing in the same place of residence.

<u>CONCESSIONARY MEMBERSHIP</u> – open to a member aged 16 years or over, who is unemployed, in full-time education, or undertaking a modern apprenticeship at the time of annual application for that year.

ASSOCIATE MEMBERSHIP – A member who wishes to partake in the social activities of the Club only.

<u>HONORARY MEMBERSHIP</u> – a position appointed by the Board to a member who has given long and outstanding service to the Club.

<u>MID-SEASON APPLICATIONS</u> – New applicants joining after 15th JULY shall be required to pay the full Entrance Fee if applicable. All other subscriptions and fees will be charged at 50% of the normal rate.

<u>MOORING & RACING FEES</u> - This fee is in respect of the use of a mooring space in the area leased by the club, from 1st April to 30th September and also entitles the member to participate in the Club Series Races for the season. The fee is calculated at the rate shown per foot of overall length rounded up to the nearest foot. An application for the continuance of a previously allocated mooring space shall be accompanied by the appropriate fee and submitted at the same time as the membership renewal application.

<u>SUMMER STORAGE FEE</u> - This fee is in respect of the allocation of a space in the Club Compound from 1st April to 30th September. The fee is calculated as the rate shown per foot of overall length rounded up to the nearest foot. All other conditions relating to the Summer Storage Fee are the same as for the Mooring and Racing Fee shown above.

DONATION TO RNLI FUNDS - This fee is mandatory with al membership applications. **GENERAL**

INSURANCE -The minimum Third Party Indemnity required for all member yachts is £3,000,000.

The Committee strongly recommends that owners obtain fully comprehensive insurance in respect of their craft.

INSURANCE CERTIFICATES - The provision of insurance cover is the sole responsibility of each boat-owner. The Club, as a service to its members, requires that a copy of the Certificate of Insurance, for all member yachts must be submitted for inspection by the Secretary along with the mooring application. Applications submitted without a copy of a valid insurance certificate will not be accepted and will be returned unprocessed.

<u>REFUNDS</u> - Membership and Entrance Fees, once paid, will not be refunded except at the discretion of the Board of Directors in cases of financial hardship and then repayment shall be pro-rata with the unexpired part of the season.

<u>CLUB RULES</u> - A copy of the Club and Mooring Rules are located adjacent to the clubroom notice board, or on request from the Secretary.
